PRODUCT DESCRIPTION

External door ED78 thermo with glazing is an outward-opening external door. The thermo exterior door is a more insulated and energy-efficient exterior door with a more efficient heat-insulating material. Designed to be used in the external perimeter of a building.

Exterior doors can also be ordered with inward opening and two gaskets, one of which is located in the frame.

Size: standard M9-10 x M20-21 (other sizes available)

Door leaf: straight edge, thickness 78 mm

Frame: pine, depth 105 mm

Threshold: oak-aluminium, height 25mm

Standard fittings: lock case, striking plate and hinges from Assa Abloy

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

Raw materials are transported by lorry from the supplier's site to the Door factory, and the calculations take into account the distances travelled by lorry.

The production process begins with unpacking raw materials. After processing raw materials, the door stiles and rails will be assembled, outside sheet materials, core added and glued together by the pressing method. After the door is pressed, it will go through machining and then get a surface coating. After surface coating, doors will dry and will be equipped with the necessary ironmongery, glazing and seals, and when needed assembled as a set with the frame.

Final quality checks will be conducted before packing the door onto transportation pallets. After that, the products will be ready for transportation to the construction site. Production losses have been considered in ancillary and manufacturing wastes. Metal waste consists of steel paint cans. These are modelled in A3 as ancillary material. Surface coating emits emissions to air when drying; these have been considered separately in the declared unit weight and the weight of chemicals being used (paint, primer and solvents).

The emitted VOCs are being collected and sent to a carbon-based filtration system with an efficiency of 95%. Paint, glue and solvent leftovers and paint-contaminated materials have been considered hazardous waste and transported to a waste treatment facility.

The transportation for manufacturing waste has been calculated based on the distance between the factory and the waste processing facilities in Estonia. 20% of defective products are being incinerated in the factory

furnaces. 80% of defective products are transported to a waste treatment facility and presumed to be incinerated.

Raw wood leftovers like sawdust, woodchips, etc., are being burned in factory furnaces. It is assumed that metals will be recycled and everything else incinerated.

Co-product allocation has not been used.

The use of green energy in manufacturing is demonstrated through contractual instruments (GOs, RECs, etc.), and its use is ensured throughout the validity period of this EPD.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The typical installation distance was assumed to be a weighted average based on sales. According to the manufacturer, transportation doesn't cause losses as products are packaged properly. The final representative product is transported 846.81 km by freight, lorry >32 metric ton, EURO5 and 90.41 km by freight sea ferry.

Environmental impacts from installation into the building (A5) include emissions from energy use in installation and the generation of waste at the construction site. No product waste is generated during installation. No water is needed for the installation process. Installation foam, fasteners and electricity for tools being used during installation have been excluded as the cut-off has been applied.

Packaging waste comes from the packaging used for the final products. Packaging waste is presumed to be sorted, collected and transported to the

waste facility; an average distance of 50 km has been presumed with a lorry >32 metric ton, EURO5. The waste treatment of packaging has been modelled with OneClickLCA waste treatment scenarios that correspond to the average EU scenario. The modelling includes recycling and incineration rates based on EUROSTAT data.

PRODUCT END OF LIFE (C1-C4, D)

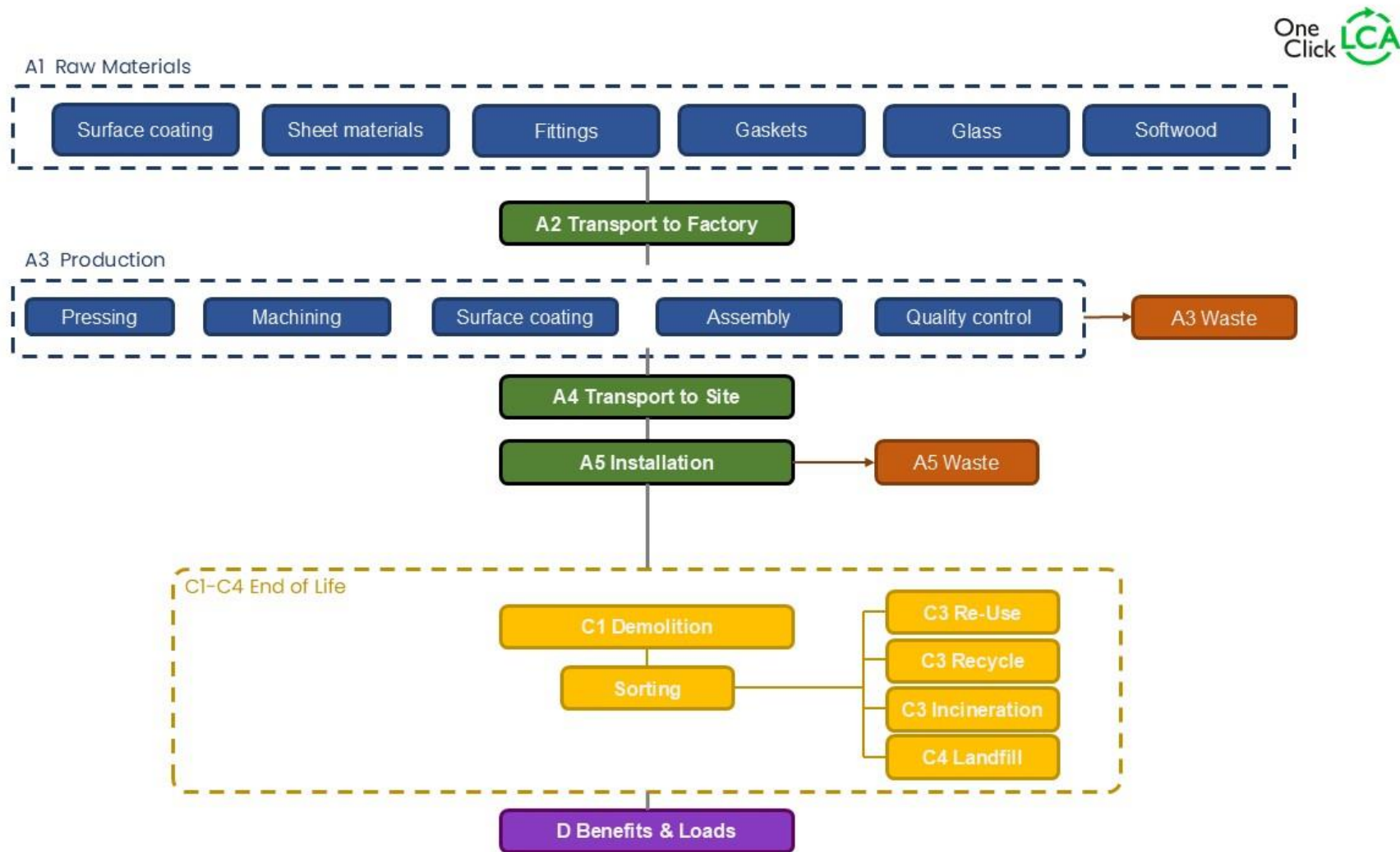
Product End of Life starts on the building site where the product is dismantled from the building, separated by material type, sorted, and the sorted materials are transported to a waste treatment facility. The majority of doors are sold to Scandinavian and Nordic countries: Sweden, Norway, Denmark and Finland. EOL scenarios have been based on reasonable conclusions by studying Swedish waste sorting regulations, where it is mandatory that building products dismantled from the building will have to be separated by material type and sorted at the building site. The link to this legislation has been referenced in the bibliography. It is estimated that there is no mass loss during the use phase of the product. Therefore, the end-of-life product is assumed to have the same weight as the declared product. Losses in the dismantling and material separation process are assumed to be very small and not considered in the assessment. It is assumed that at the end-of-life, 100% of doors are demounted using electric tools (module C1), materials are separated on-site according to local waste ordinance rules, sorted and then transported to a waste processing plant with an average distance of 50 km by >32 t lorry (Euro 5) (module C2). Materials recovered from dismantled products are considered not to have any losses and are being collected, sorted or incinerated (module C3). 100% of wood, coatings, and plastics are considered to be incinerated with energy recovery, and 100% of metals are recycled.

Module D considers the benefits and loads of energy recovery (thermal and electrical) of incinerated waste and the avoidance of material production of recyclable waste generated in Modules A5 and C3. Plastics and timber are

considered and documented with the OneClick LCA module D wood and plastic packaging EU scenarios. Paper packaging has been excluded due to its being manufactured from 100% recycled materials. Production uses mostly virgin raw materials and has avoided double-counting of recycled content, if any is present, by using our suppliers respective EPDs for the materials when available.

The used data accounts for any recycled content for the components, and we have not used this data in Module D benefits and loads.

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

On factory waste generation, we have excluded waste materials (water, general waste) that can be traced to the offices and employee communal facilities, e.g. dressing rooms, eating areas, etc. Excluded mixed waste and construction waste from repair and maintenance works in offices and communal areas for employees.

Leftover pure wood from production (ca 30%) is being used in our furnaces to produce heat for the factory. Therefore, we only buy municipal heat during very cold winters.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:
